(2)When adding new international routes or increasing the number of flights to an existing international route to Hualien, Taitung, Kinmen, Magong, Tainan or Chiayi Airport, the number of flights of the new route or the increased flights to an existing route, compared with the past year, will not be charged. (3)The minimum charge for business charter or private aircraft at the category 1 airport is NT20,000. (4)The minimum charge for business charter or private aircraft at the category 2 airports is NT10,000. (5)The minimum charge for business charter or private aircraft at the category 3 airports is NT5,000. 4. The international flights for nations of the New Southbound Policy at the category 2 and 3 airport will receive a twenty percent discount of landing charge from 1st January, 2018 to 30th September, 2019. 5. The landing charge for the international flights operate at Hualien and Taitung Airport will not be charged from 7th February, 2018 to 31st December, 2019. 6. The international flights for Japan, Korea, Hong Kong, Macau and nations of the New Southbound Policy at the category 2 and 3 airport will not be
