### 1. **Objective :**

This chapter provides guidance for preparing the production certificate.

### 2. **Instruction:** (For area numbering, refer to Paragraph 3, sample production certificate)

A. Area 1: Enter the PC number assigned by the CAA.

(Example: CAA-PC-XXX)

B. Area 2: Enter the applicant's name and address. (This should be the same person on the application for the production certificate.

C. Area 3: Enter the product items listed on the production limitation record that is attached to this production certificate.

D. Area 4: Enter the date the CAA issues the PC.

E. Area 5: Get the signature of the Director General of CAA.
