AIRWORTHINESS DIRECTIVE

This Airworthiness Directive, issued by the Civil Aviation Authority in accordance with the Israeli Air Navigation Regulations applies to an aircraft for which our records list you as the registered owner. It affects aviation safety and requires your immediate attention. No person may operate an aircraft to which an Airworthiness Directive applies, except in accordance with that Directive.

APPLIES TO: GALP model G280 aircraft, all serial numbers, certificated in any category.

SUBJECT: Revision of G280 AFM wet runway performance tables.

REASON: Updating / correcting of the Performance section.

ACTION: This AD mandates the incorporation of revision 10, or later revision approved by the Civil Aviation Authority of Israel (CAAI), of the G280 AFM (either Issue 1 or Issue 2 of the AFM as appropriate to each aircraft's configuration).

COMPLIANCE: Unless already accomplished, comply with this AD within 60 days from the effective date of this AD.

EFFECTIVE DATE: June 15, 2022.
